Northborough received the CDC Drug-Free Community Grant in 2023, (\$125,000/year for 5 years, with the option to re-apply for years 6-10).

Hired DFC Coalition Coordinator in December 2023.



Regional Grants

Northborough is the host of the PHE Grant - Greater Boroughs Partnership for Health, collaborative between Boylston, Northborough, Southborough, and Westborough.

Allocate staffing, resources, and funding to 4-town collaborative.



Opioid Settlement Funds

Gather community input from those directly affected by the opioid epidemic.

Incorporate input to identify best strategies for opioid abatement funds.



Emergency Shelter

On July 25th, the State opened an emergency shelter in Northborough with 30 families (100 individuals). The Health Department continues to serve as the primary contact.

As of 2/29, there are 22 families (80 individuals).
