- 25 Total CH115 Claims
- Grafton 5
- Northborough -4
- Shrewsbury 12
- Westborough 4

- 3 New claims since 2023.
- Since Feb 2023 there have been 2 deaths of Clients, one moved into nursing home and removed from benefits, and one returned to work.
- 3 Veterans are not retirement age but looking for work.

UNEMPLOYMENT

- Three Veterans are on employment plans and have been complying with program. One is close to having a job offer and eager to get back working.
- Masshire Worcester is a phenomenal asset for any new clients that need to update resumes or search for open positions. EOVS also partnered with Off Base Transisition Training and will be expanding its Employment referrals through Virtual Gateway.

VA CLAIMS

Disability Compensation – Most common claim for Veteran. We are averaging around 4-5 per week. C&P exams are being scheduled quickly but average time for a decision is 159.8 days as stated on VA.gov. If Veteran passes away before claim is settled, family would receive a payment from date claim was filed to date it was approved.

Benefit, no income & asset check, Tax free monthly payment. Able to increase if conditions worsen. Eligible for Property tax exemption if rated 10% or higher under clause 22E.

VA CONTINUED

- Non-service connected Pension claims. These are time consuming claims that require
 financial statements and sometimes medical records. To be eiligble the Veteran must have
 served during an approved Wartime Period and have under roughly \$150,000 in assests,
 not including a primary house. Spouse are eligble to apply for this under a deceased
 Veterans Eligbility, as long as they have not remarried.
- Aid and Attedance can also be applied for under NSC Penison if medical expenses are being paid for in home attendant or assisted living.
- Benefits Tax free payment.

VA CONTINUED

- DIC (Dependant Indemntity Compensation)
- This is reserved for Spouses of Veterans with 100% disability for +10 years or death was determined to be service connected from a condition linked to claim. Death Certificate must include a condition linked to VA disability.
- No Income or Asset limit.
- Pays 50% of Veterans payment.
- Eligble for full property tax exemption under clause 22D
- Eilgible for State Veteran Annuity \$2,000 annually.

This include service connected disability, non-service connected pension, survivors pension & DIC.

EOVS UPDATE EXECUTIVE OFFICE OF VETERANS SERVICES

- Hero Act is a bill to increase Veterans Benefits in the state.
- Aligns Veteran definition with federal definition
- Allows National Guard with deployment eligibility for CH115
- Fertility benefits for same sex female couples. Currently VA will not cover.
- RMV updates. Removing vanity plate fee and adding Women Veteran sticker for plates.
- Holyoke Veterans Home will break ground soon on new facility

WEBSITE

- Website continues to be updated and refreshed.
- Feedback received that navigating was difficult for some veterans. Graphic link buttons were adjusted to be more direct. Other changes will require more assistance from Civic Engage. One issue was Veterans were confused that different towns were showing on the banner. Adding text to the district schedule should help clear this up.
- Community spotlight has been updated and we can increase the use of this feature.

PRIORITY OF WORK

CHII5 remains the top priority of work. Receiving monthly expenses from Veterans and processing payments are ongoing task's. Monthly closeouts have been taking place in a timely manner and communicated if there is a delay. VA claims are next on the list as walk ins have been increasing in the community. We have been actively answering and returning phone calls in 24 hour windows.

OUTREACH

- This is where we have an opportunity to increase our presence in the community.
- It has been regularly reported that Spouses of deceased Veterans may not be aware of CHII5 eligibility. Local Media could be a good way to get the message out.
- Worlds Best Coffee Hour is a new outreach opportunity that Jeff will attend monthly.
- Plan summer event to spotlight the CMVSD. Goal would be to attract younger veterans but also give isolated elderly veterans social interactions with people who have shared similar experiences.

HIGHLIGHTS

- Unmarked Civil War Veteran grave was identified in Shrewsbury by Kevin Espisito. We were able to submit a request for a VA Grave Marker.
- Second Civil War Veteran was submitted for Grave Marker in Grafton.
- Grafton Trustees of Soldiers and Sailors was awarded \$8,000 grant from State to create a second Vietnam Veterans Honor Roll. It was identified that many names were missing and has been close to decade long project.
- Worlds Best Coffee hour will be co-hosted with Northborough American Legion and CMVSD.
